It's not as riveting as Dave Barry's list of Christmas presents (see Richmond Times Dispatch), but I believe it shows the hard work that the Board has done on Madison Village's behalf. During 2014 the Board:

Held the annual meeting of the Madison Village Homeowners' Association in January where Tom
Anderson, Roy Dahlquist and Tom Wilkinson were reelected to the Board for two year terms.
Held regular quarterly meetings of the Board.
Maintained appropriate oversight over association finances and worked with Community Partners to
ensure financial performance and budgeting, resulting in no change in Association assessment.
Provided regular treasury reports on the state of Madison Village finances.
Provided an active social program that allowed homeowners to interact with each other and experience
enjoyable activities.
Provided an effective architectural review process to ensure that modifications were consistent with
Covenants and Restrictions.
Maintained effective and open communication through a monthly newsletter, website and special
notices.
Maintained a community watch program and alerted homeowners to home security and crime issues.
Renewed/extended contracts with Nature's Way (grounds maintenance and snow removal),
Montgomery Irrigation (irrigation services), and Community Partners (association management).
Agreed to replace mailboxes and posts as needed.
Approved Nature's Way fertilization and pruning of maple trees in front yards along the streets.
Began a process with an attorney to revise Madison Village's Covenants & Restrictions and Bylaws; and
held a Town Hall meeting to explain these changes to homeowners.
Transitioned to our new community manager Martha Geiger.

There were a number of comments, questions and suggestions made by the attendees and we will respond to those at the January 5 meeting. Did you know that if you install your modification before you receive final approvals from Madison Village and Charter Colony, you can be required to remove or re-configure your project at your own expense? This has actually happened when projects were denied by Charter Colony. Play it safe!

Make sure your project meets meet all requirements before you start installing.

Planning on Making Any Changes or Additions to Your Property?

Don't forget whether you are planning to add new or change existing landscaping <u>anywhere</u> on your property or install improvements; i.e., attic fans, awnings, dormers, landscaping walls, pergolas, storm doors, water features, etc. those changes must be submitted to Madison Village and Charter Colony for approval. Identity Theft

The Federal Trade Commission estimates that as many as 9 million Americans have their identities stolen each year. Measures to help you from becoming a victim:

- Read your credit reports. You have the right to a free credit report every 12 months from each of the three nationwide credit reporting companies. Order all three at once, or order one every four months. To order, go to annualcreditreport.com or call 1-877-322-8228.
- Shred all documents that show personal, financial, and medical information before you throw them away.
- Create passwords that mix letters, numbers, and special characters. Don't use the same password for more than one account.

If you suspect your identity has been stolen, flag your credit reports. Call one of the nationwide credit reporting companies and ask for a fraud alert on your credit report. The company you call must contact the other two so they can put fraud alerts on your files as well. An initial fraud alert is good for 90 days.

Always remember to report anything that happens to you or your property. This helps the police determine if there is a larger problem in the area.
