#### **HOW LONG SHOULD IT TAKE FOR MY MODIFICATION TO BE APPROVED?**

How much time does it take for me to receive my approval from Madison Village and Charter Colony? Typically a properly completed Madison Village form with the plat marked and clear and concise descriptions, diagrams, attachments etc. will take no more than two weeks sometimes less.

Once you have submitted your completed modification packet to Tonya at Community Partners, it is scanned and emailed to the five committee members in one or two days. It usually takes 7 to 10 days for all of the members to review and vote on the modification. Then it takes up to 3 days for the approved paperwork to be signed, scanned and emailed back to Tonya at Community Partners. Then it usually takes up to three days for her to send out the approval letter to the homeowner and email a copy of the approved application to Vickie at Charter Colony.

Once the application is received by Charter Colony, it is put on the agenda for the next meeting of the Charter Colony Design Review Team. This team typically meets twice monthly. **It is then up to the homeowner** to complete the Charter Colony form and submit it along with a copy of the Madison Village Approval Letter to Vickie at the Charter House.

With the use of email, the review of a properly executed modification request, voting by the committee and final processing of the modification request, the ARC has greatly improved the amount of time needed to get you your final Madison Village approval.

# Planning on Making Any Changes or Additions to Your Property?

Don't forget whether you are planning to add new or change existing landscaping <u>anywhere</u> on your property or install improvements; i.e., attic fans, awnings, dormers, landscaping walls, pergolas, storm doors, water features, etc. those changes must be submitted to Madison Village and Charter Colony for approval. - If you shop or bank online, or use a public wireless network, don't send information to any website that isn't fully encrypted. An encrypted site has "https" at the beginning of the web address; "s" is for secure.
- Do not allow remote access to your computer from unknown persons. Microsoft does not call to tell you your computer has a virus and ask you for remote access to fix it.

Always remember to report anything that happens to you or your property. This helps the police determine if there is a larger problem in the area.
